- If a member's dues shall become delinquent for a period of 30 days, the delinquent member will no longer be in good standing and eligible to enjoy member benefits\*. If delinquent dues are not made current after a notice of delinquency by phone or email, membership will be terminated.

\*Member benefits include special member pricing for events, discounts from affinity partners such as Office Depot, Liberty Mutual, etc. and ability to hold leadership roles in the Chamber.
